PUBLIC COMMENTS

Pursuant to Texas Government Code section 551.007, members of the public may speak on an agenda item during the public communication section of the meeting or at the time the agenda item is called for discussion by the Mayor. Speakers shall be given three (3) minutes to speak. A speaker needing a translator and/or interpreter may be given six (6) minutes to speak. Members of the public wishing to address the Council on non-agenda items may do so pursuant to the same time constraints as agenda items. The Council will not comment on items not on the agenda; however, the Council may refer the item to City Staff for research, resolution or referral of the matter to the Council as a future agenda item.

AGENDA ITEMS

Unless otherwise indicated, action may be taken on any of the following agenda items.

1. PUBLIC HEARING: The Public Hearing on the Proposed Tax Rate and Tax Rate Increase for 2022/2023 Year will be opened.

Any resident in attendance may address the Council regarding the proposed tax rate and tax rate increase for the Oct. 1, 2022-Sep. 30, 2023 Fiscal Year.

After comments are concluded, this Public Hearing will be closed.

2. City Secretary:

- a) Resolution approving the proposed Budget for the October 1, 2022 – September 30, 2023 Fiscal Year for all City Departments, including: General Fund, Police Department, Sanitation Department, Volunteer Fire Department, Public Works Department, and the Municipal Dev. District
- b) Resolution to levy taxes at a rate of \$0.546 per \$100 valuation for the use & support of the general government for 10.01.2022 - 09.30.2023
- c) Resolution to ratify the property tax revenue increase reflected in the tax rate and city's operating budget for 10.01.2022 - 09.30.2023
- d) Ordinance establishing honorary street name policy and application
