MINUTES TO REGULAR MEETING Tuesday, October 19, 2021, 6:00 p.m.

The City Council for the City of Big Sandy met in Regular Session on Tuesday, October 19, 2021, at 6:00 p.m., at the City of Big Sandy Heritage Center, 162 E. Gilmer Street, Big Sandy, Texas.

- 1. <u>Call to Order:</u> Mayor Rozell called the meeting to order at 6:00 p.m.
 - a. Invocation Ms. Linda Baggett
 - **b.** Pledge of Allegiance Ms. Christine Jones
 - **c. MEMBERS PRESENT:** Mayor Rex Rozell, Linda Baggett, Becky Desborough, David Fonteno arrived at 6:33, Christine Jones and Andrew McIver.

- 3. <u>Items of Community Interest:</u> Reminders of several community events were mentioned.
- 4. Consent Agenda:

 - **b.** Water Bill Adjustment: Kenneth Weese: 306 N Pearl: Desborough moved to approve a water bill adjustment for Kenneth Weese for \$171.17 and Jones seconded. Baggett, Desborough, Jones and McIver voted aye. Motion carried 4-0-0.
 - c. <u>Sewer Tap Permit:</u> Kenneth Walton: 109 Mure Street: Baggett moved to table this item until a cost estimate for the tap (including boring under the road) is received. Desborough seconded. Baggett, Desborough, Jones and McIver voted aye. Motion carried 4-0-0.
 - **d.** Joanne Gonzalez: Building Inspector and Zoning Board of Adjustments: Gonzalez submitted a written request to withdraw this agenda item after the agenda was posted.
 - e. Police Department: Chief Easterling gave the activity report for September 2021
 - i. Emergency Fuel Tank Replacement for Patrol Unit #30: Desborough moved to approve the repairs at a cost of \$1,780.03 and Baggett seconded. Baggett, Desborough, Jones and McIver voted aye. Motion carried 4-0-0.
 - **f.** Public Works Department: PWD Scott Rogers gave the activity report for September 2021.

- i. Purchase of Pump from Smith Pumps: Jones moved to approve the purchase of two pumps at a cost of \$3,552.45 and Desborough seconded. Baggett, Desborough, Jones and McIver voted aye. Motion carried 4-0-0.
- ii. Radio Read Master Meters funded by the American Rescue Plan Act: PWD Rogers reported that 4 of the 365 new meters have been installed.

Appraisal District Property ID #'s: 19046 and 62681 currently owned by the Big Sandy Municipal Dev. District previously known as the Big Sandy Comm. Dev. Corporation and Jones seconded. Baggett, Desborough, Fonteno, Jones and McIver voted aye. Motion carried 5-0-0.

- **Transfer of funds to Water/Sewer Fund Reserve Account:** Jones moved to approve **Resolution #2021-029** authorizing the transfer of \$75,000 from Water/Sewer Fund to Water/Sewer Fund Reserve Account and Desborough seconded. Baggett, Desborough, Fonteno, Jones and McIver voted aye. Motion carried 5-0-0.
