- 3. Bryan McMenamy: Ordinance Variance at Upshur Co. Appraisal District ID #18257: Mr. McMenamy requested the temporary placement of two recreational vehicles at this location. Rozell moved to approve a 6 month temporary placement of two recreational vehicles providing that each RV have a separate water and wastewater connection and Allen seconded. - 8. Police Dept.: Sale or Repair of Patrol Unit #31: Fonteno moved to have the air conditioning in Patrol Unit #31 repaired at an estimated cost of \$2,945.10 and Rickard seconded. Allen, Fonteno, Rickard, Rozell and Sheeley voted aye. Motion carried 5-0-0.
- **9. Public Works Department: Monthly Report:** Public Works Director Rocky Ware presented the monthly report.
- 10. Public Works Department: Fire Hydrant Repair: Fonteno moved to approve the repair of the hydrant on Peachtree Lane at an estimated cost for parts of \$3,264.99 and Rickard seconded. Allen, Fonteno, Rickard, Rozell and Sheeley voted aye. Motion carried 5-0-0.
- 11. Award Bid for TxCDBG CDV21-0067 Highway 80 Water Main Improvements: Rozell moved to award the bid to KC Property Management LLC, the low bidder, for their base bid of \$271,020 and Rickard seconded. Allen, Fonteno, Rickard, Rozell and Sheeley voted aye. Motion carried 5-0-0.
- **12. Financial Reports for March 2024:** Rickard moved to approve the financials as presented and Rozell seconded. Allen, Fonteno, Rickard, Rozell and Sheeley voted aye. Motion carried 5-0-0.
- **13. Minutes of Meeting: March 19, 2024 meeting:** The minutes were not ready for approval at this meeting, no action taken.
- 14. **City Administrator: Ordinance: Franchise Agreement with SWEPCO:** City Administrator Rex reported that Mark Robinson with SWEPCO is planning to attend the June 18, 2024 meeting to discuss the proposed franchise agreement renewal with the city council.
