- **2.** <u>Citizen/Visitor Participation:</u> None.
- **3. Approve Minutes:** Ware moved to approve the minutes for the August 8, 2023 meeting and Hooser seconded. Hooser, Peterson, Rex and Ware voted aye. Motion carried 4-0-0.

 - **b. Sponsorship of Heritage Festival Signs:** Peterson moved to approve spending up to \$200 to purchase 8 to 10 18 x 24 plastic signs to promote the Heritage Festival and Hooser seconded. Hooser, Peterson, Rex and Ware voted aye. Motion carried 4-0-0.
 - c. **Sponsorship of Big Sandy Wildcat Band:** Hooser moved to sponsor the band with a \$250 donation and Rex seconded. Hooser, Peterson, Rex and Ware voted aye. Motion carried 4-0-0.
 - d. Business Park:
 - i. Corporate Drive: The road has been damaged apparently by logging trucks, but the city has not accepted ownership of the road. No action taken.
 - **ii. Pump House Repair:** We are waiting to receive estimates on repairs. No action taken.
 - e. Welcome Center: 106 E Gilmer Street:
 - **i. Punch List:** The board developed a punch list of items to be completed before the grand opening. No action taken.
 - ii. Grand Opening: The board is planning for a grand opening on Oct. 28, 2023 during the Heritage Festival.
