A tax rate of \$0.560000 per \$100 valuation has been proposed by the governing body of City of Big Sandy.

The no-new-revenue tax rate is the tax rate for the 2021 tax year that will raise the same amount of property tax revenue for City of Big Sandy from the same properties in both the 2020 tax year and the 2021 tax year.

The voter-approval rate is the highest tax rate that City of Big Sandy may adopt without holding an election to seek voter approval of the rate.

The proposed tax rate is greater than the no-new-revenue tax rate. This means that City of Big Sandy is proposing to increase property taxes for the 2021 tax year.

A PUBLIC HEARING ON THE PROPOSED TAX RATE WILL BE HELD ON September 8, 2021 AT 6:00 PM AT Big Sandy Heritage Center, 162 E Gilmer St, Big Sandy Tx 75755.

The proposed tax rate is not greater than the voter-approval tax rate. As a result, City of Big Sandy is not required to hold an election at which voters may accept or reject the proposed tax rate. However, you may express your support for or opposition to the proposed tax rate by contacting the members of the Big Sandy City Council of City of Big Sandy at their offices or by attending the public hearing mentioned above.
